OFFICIAL CONTEST RULES

MUST BE 19 YEARS OR OLDER TO ENTER

These are the official contest rules ("Official Rules") for the Harvest Wine, Beer and Spirits "Hockey PRIMEtime Giveaway" contest (the "Contest"). The Contest begins on October 15, 10:00AM AST, 2021 (the "Official Start Date") and all entries must be made on or before November 28, 10:00PM, 2021.

- 1. <u>ELIGIBILITY</u>. 4. HOW TO ENTER.

NO PURCHASE NECESSARY: To enter the Contest without making a purchase, print your name, address, email, and telephone number and deliver a

Written Submission to the head office location (741 Bedford Highway, Halifax, Nova Scotia) and comply with the entry requirements of these Official Rules*. Limit of one (1) no-purchase ballot entry per day during the Eligible Period. Entrants cannot submit Written Submissions that are duplicated or reproduced, and each Written Submission must be unique and the original work of the entrant submitting it. Sponsor reserves the right to reject any Written Submission it determines violates these Official Rules, in its sole discretion.

All entries to the Contest become the property of Sponsor. Entrants who have registered through fraudulent means or have provided false or misleading information will be disqualified.

- 5. <u>WINNER SELECTION</u>. All Eligible Entries received from Eligible Period will be entered into the Prize draw. On December 3, 2021, there will be a random draw for the Prize at the offices of the Sponsor.
- 6. WINNER NOTIFICATION. Within (14) fourteen days of a potential Prize winner being selected for a Prize they will be contacted at the email or telephone number recorded in respect of the entrant's entry. - 9. <u>PERSONAL INFORMATION</u>. By entering the Contest and voluntarily providing your personal information as described in these Official Rules, you agree to the collection, use and disclosure by Sponsor and its respective employees and/or authorized agents of your personal information for the purpose of administering the Contest, including—but not

- limited to—contacting you with respect to the Contest if you are a selected entrant. Personally, identifiable information will only be used to administer the Contest and for no other purpose
- 10. Sponsor shall have the right to publicize a Prize winner's name, photograph, likeness, and village/town/city in association with this Contest. The Grand Prize winner shall make themselves available for photographs for this purpose.
- 11. <u>ACCOUNT HOLDER</u>. In the event of dispute over the identity of the potential Prize winner, an Eligible Entry will be declared as entered on the ballot used to submit the Eligible Entry, and the potential Prize winner may be required to provide identification sufficient to show that they are the authorized entrant.
